

Portal Registration & Submitting Work Statements

Portal Registration

- February 1: Portal registration opened
 - All staff who will review applications should register for their own accounts
 - Office not on the list? Contact Christine Rovner (crovner@aaas.org)
- March 14: Last day to register for portal

Submitting Work Statements & Hosting Agreements

- March 3: Last day to submit SOWs to STAS office for review
 - Send to JC Vargas, VargasJC3@state.gov
- March 15: Deadline to submit your work statement and other template information ("position description") in the portal
- March 24: Deadline to submit Hosting & Funding Agreement
 Send to JC Vargas, VargasJC3@state.gov

- Assess your office's needs to help you envision how a scientist or engineer may add their expertise or skills to the mix. Consider cross-cutting and collaborative opportunities for fellows.
- Use clear language and descriptions to ensure that fellows with little or no experience in government can understand your office's mission, programs, and their anticipated role. Highlight where the office engages/interacts with policy.

Describing the Position



Position Description Tips

- Indicate the clearance needed to accomplish the office's work
- Changes after finalizing? Contact Christine Rovner (crovner@aaas.org)
- "Clone" to create similar positions.
 - But use unique position names!
- Default is to allow finalists to contact offices to request interviews. Select "Do not contact" if you do not want finalists to request interviews.

Office & Fellow Commitments



- All fellowship terms are for one year with the opportunity to renew for a second year
- Some applicants in the portal may only wish to serve one year – ask in the interview
- Offices may elect to use a bureaufunded FTE; please note on the Hosting & Funding Form

Portal Registration & Submitting Work Statements



- March 17: Offices may begin review of finalist materials in the portal
- March 22: Offices may begin to schedule interviews
- April 12 at Noon ET: Pre-scheduling period closes
- April 17-21: Finalist Interview Week



Finalist Interview Week Format

STPF will resume an in-person Finalist Interview Week!





Interview Tips

- Include colleagues in interviews.
- Highlight projects with potential for a high amount of ownership for the fellow.
- Discuss collaborations with partners outside your office, engagement in the interagency.
- Give finalists a holistic view of office activities
- Highlight past fellow experiences and any alumni currently in the office.



Current fellows may not participate in finalist interviews, review finalist materials, or participate in the evaluation process in any way.

Interview Tips cont.

- Be flexible when considering a fellow's background. A fellow with an unexpected discipline or experience may still have the skills that your office seeks.
- Mentoring matters in this professional development program. Let fellows know that your office has the capacity to provide them with appropriate training and meaningful feedback.
- Reach out to your program manager with your questions about the STPF program!

Interview Scheduling & Interview Week



Ranking and Offers

April 26: Rankings Due

- Must be entered by person who added position to portal.
- Do not tell finalists how your office ranked them or how "highly interested" you are.
- Do not rank finalists you do not wish to host.

May 3: STPF Begins Offer Sending Process

All placement offers are made by STPF on behalf of host offices.



May 3: STPF Begins Sending Offers



- All fellowship placement offers are made by AAAS STPF on behalf of prospective host offices.
- Finalists may receive multiple offers at the same time.
- Finalists may reach out to offices during this period with additional questions.
- We appreciate your patience as the process unfolds!

Rankings Submission & Placement Offer Process

Onboarding

- STPF will send a formal fellowship placement offer and terms to fellows in June
- Placements begin on August 28, 2023*
 - STPF Orientation –September 5-8 and September 11-13 (excluding Labor Day)
 - Agency-specific onboarding TBD
- * State Department fellows hired under the Schedule A mechanism begin their first fellowship year on August
 28 or after receiving their security clearance; fellowship renewal dates are based on the EOD date.
